## TN - BEAT EXPO 2024 - TERMS AND CONDITIONS OF PARTICIPATION

- 1. RIGHTS: The Organizers reserve all rights in connection with the Exhibition "TN-BEAT EXPO 2024" A B2B & B2C Expo, organized at Chennai during Jan 26th to Jan 27th, 2024.
- 2. Terms of Reference & Definitions: In these Terms and Conditions, the term "Exhibitor" shall include all owner, partners, directors, employees and agent of any company or individual inclusive of any Government /Semi Government body / Corporation, to whom space has been allocated for the purposes of participation. The term "Organizer" shall mean: TAHDCO (Tamil Nadu Adi Dravidar Housing and Development Corporation Ltd.,)
- **3.** The term "Terms and Conditions" means the Terms and Conditions hereinafter contained. The term "Application" means the contract for space at the Exhibition entered into between the Organizers and the Exhibitors.
- **4. BUILT UP STALL:** The minimum area is 6sq.mtr or 9 sq.mtr. And any additional space required will be in multiples of 6 or 9 sq. mtr. The Built-up stall will be constructed of octanorm system with normal height of 2.5 mtr, having white panels. Each stall will be provided with the following furniture and fittings FREE OF COST: 1 Table, 2 Chairs, 3 Spotlights, 1 (5 amps) Plug point, Dust Bin, Carpeted Flooring. The official vendor for stall construction will put up the Exhibitor's name and stall number on the fascia board. It is not allowed to attach any additional texts, logos, etc. on the fascia board.
- **5. Payment Terms & Conditions:** The possession of the stall will not be allowed till all dues are cleared by the exhibitor. Exhibitors should get the confirmation of participation letter from the Organizers after clearing all the dues before taking possession of the stall allotted to them. Invoices will be sent to all Exhibitors and payments for stall charges shall be made as follows:
- **6. Stall Alteration:** (a) No alteration to the size or position of an exhibitor's stall is permitted without the prior written approval of the Organizer. (b)The Organizer reserves the right to modify the floor plan and the pathways at any point of time.
- c) The Organizers reserve the right to require exhibitors to make such alterations to their stalls (special or designer stalls), or to the shifting of exhibits, as they reasonably feel necessary, to maintain an acceptable standard of presentation or to avoid interference with the displays of other exhibitors. d) Conversion of an allocated built-up stall to bare space type is not permitted. e) Usage of nails, pins, screws, or any such material on the octanorm wall panel of the built up stall is not allowed. Damages if any will be liable for compensation by exhibitors.
- 7. **Equipment interference**: No equipment can be operated which emits excessive noise or causes electrical interference or annoyance to other exhibitors. In this matter, the decision of the Organizers will be final.
- **8. Exhibition Hall Cleaning:** All pathways and common areas alone will be cleaned daily by contractors appointed by the Organizers. All Exhibitors are responsible for cleaning of stall, exhibits and the general tidiness of their stalls.
- **9. Electrical Supplies:** The Organizers will be providing the lighting in the exhibition hall in addition to the normal stall lighting. Power Supply will be switched off 15 minutes after the closure of the exhibition on each day.

## 10. Electrical Installation:

All on-site electrical installations MUST be carried out by the officially appointed Electrical Contractor. All specific power requirements should be applied for giving proper details and electrical drawing as per acceptable standards of safety. All prefabricated electrical fittings will be subject to an inspection by the official contractor before connection to the mains supply. Payment for extra electrical connection and consumption should be made to the Organizers at applicable rates.

#### 11. Additional Furniture/Fittings:

Your requirement of additional furniture/fittings can be availed of from our official stall contractors at the venue. Payment for the extra requirement is to be made to the contractors on receipt of such bills from them before providing such services.

- **12. Damage to Exhibition Areas:** Exhibitors are liable to indemnify the Organizers against any claim made against them in respect of damage to Exhibition Hall, Structure or property, Octanorm stalls etc., caused by exhibitor's, or staff or by agents acting on Exhibitor's behalf.
- 13. Flammable Materials: All materials used in the construction of stalls and displays are to be fully fire proofed and comply with all local regulations. The exhibitors shall ensure that no hazardous chemicals, gases, fire arms, etc., are kept in the stalls.

- **14. Fire Extinguishers:** The Organizers will provide fire extinguishers to meet requirements of the overall layout of the exhibition and the fireman will be available to attend in case of any emergency.
- **15. Security:** Although strict security arrangements will be provided at the exhibition venue by the organisers, exhibitors are requested to have their own arrangements of security at their stalls if needed. Exhibitors are free to ensure their equipment and other personal belongings are properly insured.
- 16. Insurance and indemnity: a) Third party Claims: The Exhibitors are responsible for all personal injury or damage to property or personnel, arising out of erection, dismantling and overall participation in the exhibition. The Exhibitors must take out adequate insurance in respects. (b) Consequential Loss: Exhibitors are advised to insure against costs and losses which they may incur in the event of the exhibition being abandoned, cancelled or suspended in whole or in part for causes not within the Organizers control, since the Organizers accept no liability in such an eventuality. © Product Liability Insurance: Exhibitors are advised to insure against claim arising out of body injury and / or property damage due to exhibit display in the stall. An Exhibitor shall produce to the Organizer on demand Certificates of such Insurance.
- 17. Parking: Free Reserved Parking facility is available for the Exhibitors at the venue for 4 wheelers and 2 wheelers.
- **18. Force Majeure:** The Organizer shall not be liable to the Exhibitors for any cancellation or part-time opening of the exhibition, either as a whole or in part, for any non-performance of their obligations under this contract for any amendments or alterations to all or any of the Terms and Conditions of the Exhibition in each case to the extent that such occurrence is due to any circumstances not within their control.

### 19. Subletting of Stalls:

The Exhibitor must not transfer, dispose of, part with or otherwise sublet the whole or any part of allocated exhibit space, whether for financial consideration or otherwise. The Exhibitor must, if he is an agent, distributor or licensee, state at the time of booking the names of their principal company (is) they represent in the exhibition. This does not prohibit an Exhibitor displaying the products of a principal for whom he becomes agent, distributor or licensee after the time of contract, with the prior written permission from the Organizers before the commencement of the exhibition.

- **20. Verbal Agreements:** Any verbal agreement concerning any particular clause / rule of this contract or the Exhibition are not valid unless confirmed in writing.
- **21. Jurisdiction:** Any disputes between the Organizers /agents and an exhibitor are subject to CHENNAI jurisdiction only.
- 22. Acceptance of Rules: The very fact that an Exhibitor participates in the Exhibition as an Exhibitor, implies without any dispute that he / she, his / her company / Organisation has read the Terms & Conditions formulated by the Organizers and as printed herein and irrevocably confirm to abide by them. This is applicable to each and every participant irrespective of the amount or percentage of payment made to the Organizer and includes participants, exhibitors / co-exhibitors as well as companies / organisations with complimentary stalls, irrespective of the fact if they have signed or not signed the registration form or any other document.
- 23. The Organisers can reject any application for space without assigning reason
- **24.** The Organisers have the rights to postpone, extend or abandon the exhibition or close some or all sections of it temporarily or permanently, under unforseen circumstances.
- **25.** The Organisers have the rights to refuse permission to any Exhibitor to clear his stall if he has not paid all dues to the Organisers or to retain the exhibits or other goods as collateral security till such dues are paid.
- **26.** All efforts will be taken by the organizers towards making arrangements for B2B meetings on fixed appointment basis. However such meetings are wholly and purely subject to the willingness of the concerned parties to the meeting and under no circumstances the Organisers will be liable for any compensation in whatsoever manner.
